WHEREAS, the City of Norwich is an entitlement community receiving U.S., Department of Housing and Urban Development (HUD) Community Development Block Grant (CDBG) dollars and through its Property Rehabilitation Program received Return of Loan funds (RLF) and is allowed, by regulation, to utilize up to 20% of these (RLF) dollars expended to generate CDBG Administration funds.
